Terms and Conditions—ENERGY STAR Appliance Program

Program Offer: The Program covers products purchased and/or services rendered **on or after January 1, 2010**.

Eligibility Requirements:

1. Appliances must meet ENERGY STAR Criteria* and be listed as an ENERGY STAR qualified product at the time of purchase. The ENERGY STAR lists of qualified equipment are updated periodically.
2. Member must provide the Cooperative with proof of purchase that includes appliance model and serial numbers.
3. Appliances must be connected and served by the Cooperative providing the incentive.
4. Refrigerators must have a volume of 3 cubic feet or more.
5. To be eligible for dishwasher rebates, the member must have an electric water heater installed in the home. Eligibility for clothes washer rebates require member to have an electric water heater or electric dryer installed. Model and serial numbers for this equipment will be required on forms before reimbursement.
6. High Efficiency ENERGY STAR Televisions—units must have a minimum 40" screen (measured diagonally) and qualify under the ENERGY STAR Version 4.1 standard. You can find ENERGY STAR qualifying television products on the ENERGY STAR web site at www.energystar.gov. From the home page, select "Find ENERGY STAR Products" (in the Products section) and on the products page select "Televisions" (under the "Computers & Electronics" section). The Televisions page has an area called "Televisions Resources" that has a "Find a Model" link which allows you to search for ENERGY STAR qualified televisions by a number of criteria, such as brand or size. The direct link to a PDF list of qualified televisions (at the time this form was published) can be downloaded at http://downloads.energystar.gov/bi/qplist/tv_prod_list.pdf. Only units on this list with a screen size of 40 inches or more will qualify for this incentive program.
7. Member must provide Energy Star Verification (see below).

ENERGY STAR Verification:

ENERGY STAR qualification can be verified by one of the following:

1. Provide cutout of package showing ES logo, product type and model.
2. Provide copy of yellow EnergyGuide label with ENERGY STAR logo.
3. Provide printout from Energy Star website showing that the model is ENERGY STAR (REQUIRED for TV's).

Warranty Information:

Under no circumstances shall the Cooperative be liable for any consequential or incidental damages resulting from participation in this Program. The Cooperative will not be responsible for any tax liability that may be imposed on the Participating Member as a result of the payment of Program Incentives.

Participating Member's Certification:

Participating Member certifies that he/she purchased and installed the equipment listed in their application at their defined location served by the Cooperative. Participating Member agrees that all information is true and that he/she has conformed to all of the program and equipment requirements listed in the application.

Program Changes/Termination:

While this rebate program will be in effect for an indefinite period, the Cooperative reserves the right to extend, modify (this includes incentive levels) or terminate this Program without prior or further notice. The member is responsible for checking with the Cooperative to determine whether the program has been changed or is still in effect.

Other Conditions

The Cooperative reserves the right to inspect installations before issuing the rebate. If the application does not comply with the Cooperative's rules and qualifications, the rebate amount may be adjusted.

Members must apply for rebates within 6 months of the purchase date (as shown on the member's invoice). Past eligibility, however, does not guarantee that equipment will meet criteria for current programs in effect.
