They must be ready to leave the comfort of their home and families unexpectedly, and they don't return until the job is done, often days later. 

At Eastern Iowa REC, we are experts at delivering electricity to your home, farm or business. We also try to help Cooperative members make the best use of their energy dollars. The Cooperative offers a range of rebates for members who install energy efficient heating and cooling equipment. The Inflation Reduction Act (IRA), signed by President Joe Biden on August 16, 2022, includes several tax incentives, that when combined with the Eastern Iowa REC rebates, can increase the savings.

For the next ten years, 2022-2032, the Residential Clean Energy Credit (IRC Sec. 25D) will provide a 30% tax credit for geothermal heat pumps, solar panels, solar thermal systems, fuels cells, small wind systems, biomass heat-

120,000 electric lineworkers. Eastern Iowa REC has 42 lineworkers that are responsible for keeping power flowing 24/7, 365 days a year. To do this, they maintain more than 4,800 miles of power lines across all or parts of 12 counties. In addition to the highly visible tasks lineworkers perform, their job today goes



far beyond climbing utility poles to repair a wire. Today's lineworkers are information experts who can pinpoint power outages from miles away. Line crews now use laptops, tablets and other technologies to map outages, survey damage and troubleshoot problems.

Being a lineworker may not seem like a glamorous job, but it is absolutely essential to the life of our community. Without the exceptional dedication and commitment of these hardworking men and women, we simply would not have the reliable electricity that we need for everyday life.

So, the next time you see a lineworker, please thank them for the work they do to keep power flowing, regardless of the time of day or weather conditions. Inflation Reduction Act includes geothermal, solar, EV incentives

ers, and beginning in 2023, battery storage systems.

For Cooperative members considering the purchase of an electric vehicle (EV), starting this year, a \$4,000 tax credit is available for the purchase of a used EV and a \$7,500 tax credit is avail-

able for the purchase of a new EV. This tax credit is not available on all brands. To qualify for the credit, the EV must have final assembly in North America. In 2024, the tax credit will be issued through the dealership at the time of purchase.

For Eastern Iowa REC members, a rebate of \$500 per ton is available for new closed loop geothermal systems and a rebate of \$200 per ton is available to members who are replacing their geothermal unit on an existing closed loop system.

The Cooperative also offers rebates on the installation of Level II EV chargers. The rebates is 50% of the installed cost up to \$350. The installed cost includes contracted labor only and does not include internal labor.

Cooperative switching to the Iowa Statewide Interoperability Communication System

Communication is a key to any successful business and this is very true at Eastern Iowa REC. A recent change to the Cooperative's two-way radio system is an effort to improve and enhance communication with personnel working in the field.

Earlier this year, technicians installed new Motorola radios in Cooperative vehicles as part of the company switching to the Iowa Statewide Interoperability Communication System (ISICS). The ISICS is a statewide radio platform that provides microwave-based radio communication to public safety agencies and others (including Iowa's rural electric cooperatives), border to border in the state of Iowa, to improve public safety across the state.

Moving to the ISICS allows the Cooperative to take advantage of the systems of towers the state of Iowa has constructed and maintains. It frees the Cooperative from having to maintain its own set of towers. It also will make mutual aid work easier by allowing crews from other electric cooperatives to communicate using a shared frequency.

The new system seemed to work well in its first test following the ice storm on Feb. 23-24. Multiple vehicles and personnel were working throughout the northern portion of the Cooperative's service territory without communication issues.

SmartHub is a complete source for bill information

If you have questions about your Eastern Iowa REC bill, the answer may be just a few key strokes away using SmartHub.

Eastern Iowa REC members can use the SmartHub website or app to access important information like bill amount, energy usage and billing history.

Cooperative members can view actual usage data through detailed graphs and monitor daily consumption 24/7 with SmartHub.

Reviewing energy usage information allows Cooperative members to recognize usage patterns and possibly help identify times they can try to cut back on energy consumption, saving both money and electricity.

SmartHub offers paperless, convenient access to your Cooperative energy bill.

View and pay your bill on your mobile device or on the web and eliminate the need to receive a paper bill by going paperless with SmartHub.

• Pay bills.

• View, print or download current and previous billing statements.

- Access accounts 24/7.
- Review electricity use.
- Set accounts up for automatic pay ment.

After downloading the SmartHub app, you will need to search for Eastern Iowa Light and Power Cooperative to ensure you have the correct version.

and affordable electric service to its members through the efforts of an entire team of dedicated employees.

A variety of factors like extreme weather and increased use of renewable energy are affecting


the electric utility industry so much that there's even a new way to talk about it: resilience.

You might be surprised to learn that "resilience" isn't exactly used to describe the major changes affecting electricity service. Instead, it's about actionable steps electric utilities are taking to keep power flowing.

Just a few years ago, "reliability" was the term of choice. Reliability meant trimming trees near power lines and keeping squirrels from chewing up electrical equipment. Attention to those priorities worked. The average American's electricity stayed on well over 99.9% of the time. Eastern Iowa REC members experienced an average of 1.33 hours of outage time in all of 2022.

More powerful and frequent natural disasters call for all electric utilities to learn new ways to do their job.

"Reliability" and "resilience" are not the same. The Future Electric Utility Regulation Advisory Group compares electric service to a boxing match: "Reliability is when you can



Grid resiliency is the ability to withstand and recover from disruptive events and to predict and adapt to ensure consumers have the reliable power they need in a time of new energy challenges.

Electricity is more important than ever to our daily lives. At the same time, weather events can suddenly take that essential electricity away from large numbers of people. Utilities need to be ready to get back up off the canvas quickly. And that's what they're doing, from burying more power lines underground to outage recovery plans that get the most essential services back online first.

We are focusing on cybersecurity. We are working closely with our power supplier, state and national association, and other business partners to share information to protect against the latest cyber threats. It is an ongoing and constantly changing process.

We are investing in new equipment and sensors that can more quickly detect and resolve power outages or other problems.

We have worked to harden our distribution by rebuilding sections of line with new materials and new designs to make them more resistant to the forces of Mother Nature.

There's no doubt that major changes to the way we generate and consume energy are happening. But utilities, including our Cooperative, are answering the call with innovative solutions to serve our local communities. That's called resilience.
