

Eastern Iowa REC Election Nomination Process

The Cooperative has an open nomination process for those wishing to seek election to the board of directors. Potential director candidates are asked to submit an address verification form. This will enable the Cooperative to ensure the potential candidate is eligible to run within the district they indicate on the form. The candidate then must complete a petition signed by at least 15 memberships of their district and fill out a brief biographical form which is then published in the Cooperative newsletter, Current News, prior to the election. The nomination process puts no limit on the number of candidates in a given district. All nomination paperwork is available on first business day of January and candidates have until the first week in April to return the paperwork.

Election for positions on the Board of Directors are held during a series of District Meetings that are held each summer. Cooperative members must attend these meetings to cast their votes. Directors elected at the District Meetings begin their terms of office at the Cooperative's Annual Meeting, which is held on the first Thursday after Labor Day each year.

According to Article VI, Section 5, of the Cooperative's Articles of Incorporation, the qualifications for serving as a director of Eastern Iowa Light & Power Cooperative are as follows:

No person shall be eligible to become or remain a director or hold any position of trust in the Cooperative who:

1. Is not a member and bonafide resident in the District he/she is to represent.
2. Is in any way employed by or financially interested in a competing enterprise or business selling electric energy or supplies to the Cooperative, or a business primarily engaged in selling electrical or plumbing appliances, fixtures or supplies to the members of the Cooperative.
3. Nothing contained in this section shall affect in any manner whatsoever the validity of any action taken at any meeting of the Board of Directors.
