## **Incumbent director won't seek re-election**

Eastern Iowa REC Director Dan Heater announced at the most recent board meeting that he will not be seeking re-election to the Board representing District 4. The Cooperative thanks him for his years of service to the organization.

Elections for positions on the Cooperative's board will be held at the District Meetings this summer. Those interested in seeking election to the board can start the process by submitting an address verification form, which enables the Cooperative to ensure the potential candidate is eligible to run within the district they indicate.

The next step is for the candidate to complete a petition signed by at least 15 memberships of their district by April 3.

Nomination packets, along with information regarding the district boundary map, qualifications to seek election, director compensation, director duties, responsibilities, Standards of Conduct and characteristics of a director can be found on the Cooperative's website, www.easterniowa.com under the "My Coop" tab, Director Elections or call 1-800-728-1242 to request the information.

Today's consumers want and expect options, including the type of energy powering their homes. Many homeowners are looking for a less expensive form of energy with ongoing savings. Some are looking for a green energy source. These two motives are why many homeowners are exploring solar panels.

The interest in alternative energy sources is also being fueled by decreasing costs for solar, the availability of financial incentives and the proliferation of companies offering solar panel installation.



In addition to Director Heater, the following incumbent directors' terms expire in 2023: Joel Carstensen, district 1; Mike Bixler, district 2; Mike Shuger, district 3; and Ron Stover, district 5.

All candidates who submit qualifying petitions will be asked to fill out a brief biographical form and return it to the Cooperative by May 15. The elections will be held during the 2023 district meetings.

# Applications are due this month

The application deadline for two Eastern Iowa REC youth programs are this month.

The deadline for the Cooperative scholarship program is March 10, 2023 and the deadline for the Youth Tour program is March 17, 2023.

The 2023 Eastern Iowa REC scholarship program includes 21 \$1,000 scholarships.

The "Bob Wiemerslage Memorial Scholarship" is awarded to a student whose parents or guardian is a member of the Cooperative and who plans to major in accounting. Wiemerslage was the Cooperative's Division Manager of Accounting until his passing in 2019.

Fifteen scholarship winners will receive a \$1,000 award, three in each district, that can be used to help defray the costs of attending any accredited college or university.

Five \$1,000 scholarships will be awarded to students planning to pursue a trade-related degree at a community college, technical school or powerline school.

The Cooperative's scholarship program is open to all 2023 high school seniors, whose parents or guardians are members of the Cooperative. includes children of Cooperative directors and employees.

The deadline for applying for the scholarship program is March 10, 2023.

The 2023 Youth Tour trip to Washington, D.C. will be June 17-23. Iowa students will join other student leaders from across the nation to learn more about cooperatives, U.S. history and government.

# Lineworker training programs supported by Eastern Iowa REC

For Eastern Iowa REC lineworkers, the first step in their Cooperative careers begins in the classroom.

One of the main requirements for any apprentice lineworker hired by the Cooperative is that they have completed a certified powerline program.

The Cooperative helps fund scholarships at such programs at Northwest Iowa Community College (NWICC) and Marshalltown Community College.

Funding for these scholarship programs is drawn from funds accumulated from unclaimed patronage dollars.

In the past, these unclaimed dollars were returned to the State of Iowa coffers, but the Cooperative is now allowed to use these funds to support specific programs to promote education or economic development.

In 2023, scholarships from NWICC's program were awarded to Drake

Johnson, Danville; and Ethan Unzicker, Danville. The 2023 Marshalltown Community College scholarship winners were Tyler Jackson, Wilton; Nolan Ostrom, Solon; Leighton Tjaden, North Cedar High School; Jacob Anderson, Calamus/Wheatland; Zach Galvin, Linn-Mar; Alan Kriegermeier, Jefferson; Trevor Long, Linn-Mar; Noah Jackson, Delaware County; Rashon Burrell, Black Hawk County; and Tyler Rundle, Jones County.

- current rate schedule
- tree coverage near the home/building
- estimated return on investment (ROI) for appropriately-sized system

Unlike a solar company that has one objective—to sell their products and services—we will look at the total energy picture and help you determine the best options for your home. While rooftop solar certainly works for many people, it's not the answer for all.

When helping Cooperative members determine whether rooftop solar is right for them, a Cooperative energy advisor will also discuss the financial considerations:

- Is there a large, up-front payment required or are fees spread out over time?
- Will the homeowner own the panels or will they be leased?
- Are there any hidden costs, i.e., does the roof need to be replaced before installing the panels?
- Are there ongoing maintenance fees?
- Are there rebates or other financial incentives available?
- Is the estimated energy savings worth the investment?
- Is it more cost effective to invest in other energy saving measures?
- Will adding solar have an adverse effect on other incentivized rates (heat plus or super off-peak)?

Most importantly, an energy advisor will provide perspective on the total energy puzzle. Taking into account current energy consumption, the home "envelope," age and efficiency of the HVAC system and home site, an energy advisor can help Cooperative members determine whether rooftop solar is the best choice given the homeowners'

When assessing solar options, it is an excellent time to examine other potential energy efficiency improvements for your home. For example, it may make sense to insulate the attic at the same time as installing solar.

## Comments from the CEO

# We are focused on sustaining a reliable electric system

We've all heard the phrase, "Don't put all your eggs in one basket." This popular adage is often used in conversation or a story when someone is about to do something foolish or risky. If they heed this advice, it means they did not commit to "one basket", but instead hedged their bets with multiple options.

This strategy is how I describe Eastern Iowa REC's common sense approach to the current energy transition. We know that consumer interest in renewable energy continues to grow. We've seen this trend here in Iowa.

Recent innovations and advances in renewable energy technologies have led to sharp decreases in costs, making renewables more feasible, accessible and scalable. Over the last few years, your Cooperative's power supplier, Central Iowa Power Cooperative (CIPCO), has adjusted its fuel mix by utilizing more renewables. Today, 36.8% of the CIPCO fuel mix is comprised of wind and solar assets.

CIPCO invests in the development of renewable energy projects in several

ways. They operate six small-scale solar arrays near communities throughout CIPCO's service territory. They retain the renewable energy certificates associated with each.

CIPCO also contracts with energy

producers for the electricity output from the Wapello Solar array, wind, hydro, and methane gas from a landfill (converted into electricity). CIPCO cannot claim these resources as renewable within the CIPCO supply port-

folio as they have either been sold to third parties or they do not receive the renewable attributes associated with the electricity produced from these renewable power sources.

By selling these attributes, CIPCO not only supports other organizations in meeting their renewable energy goals, CIPCO also generates revenue to help them lower their wholesale power rate.

Nationally, there is increasing reliance on renewable energy sources at the same time that we're seeing fossil fuel plants taken off-line, often ahead of schedule. Additionally, we're seeing more pressure on the electric grid due to the increasing frequency and intensity of severe weather events and rising electricity demand.

So how do we reconcile these challenges of grid pressure and a changing fuel mix? Solar and wind energy are certainly beneficial for the environment, but they are limited resources because the sun does not always shine, and the wind does not always blow. Our primary responsibility is to provide electricity 24/7 to you and our community. To do this, we need reliable sources of power that will meet all the peaks and valleys of on-demand energy in our connected world.

So where are we netting out? That's where our familiar adage comes into play. While utilization of renewables is increasing, we still need to incorporate other forms of energy in the mix to ensure reliable service. Remember, solar and wind are intermittent power sources. This fact coupled with the growing demand for renewables creates its own challenges.

That's why we spread our eggs into multiple baskets. There is great value in maintaining a diverse mix of fuel sources—fossil fuels and renewables to ensure reliability, resiliency and meet the growing demand for electricity.

Reliability also means repairing and replacing utility equipment to prevent wear-and-tear, ensuring our equipment can withstand severe weather. We are laser-focused on providing Eastern Iowa REC members with reliable, affordable energy. That's why fuel diversity—or placing our eggs in multiple baskets—is essential to reliability.

As our nation increasingly depends on electricity to power the economy, Eastern Iowa REC is working to anticipate, plan and respond to market trends and policy shifts. That's how we can power your home and our economy, while continuing to serve as your local energy provider.

## Electric co-ops advocate for rural Iowa priorities

More than 150 directors, managers and employees from Iowa's electric cooperatives discussed priorities with over 100 state legislators on January 10 during a 2023 Welcome Back Legislative Reception in downtown Des Moines Jan. 10.

The event provided a valuable opportunity to meet with state legislators at the beginning of the 2023 Legislative Session to discuss issues that impact rural electric cooperatives and the communities we serve.

For example, we're concerned about secretive industrial and commercial corporations that are seeking to circumvent Iowa's electric service territory laws; these protections exist to provide stability for Iowa homes, farms and businesses. Iowa's electric co-ops are also opposed to any legislation that would deny landowners the option to use their property for utility-scale solar generation if they so choose.


